Once an order has been executed (transfer user to user, deposit BTC in your cash wallet or request of payout) and the appropriate currencies have been credited and debited from the Members' Accounts, we will not be able to reverse the transaction under any circumstances.

### **Changes to Registration Data**

You must promptly inform/update us of all changes, including, but not limited to, changes in your address and changes in any virtual or dollar currency account used by you in connection with the Site and Services, if applicable. - b) The Assignor is prevented from making new membership in the club for a period of 90 days, counting from the date held.
- c) All points accumulated in the binary will be flushed upon transfer.
- d) Affiliates who sign this agreement agree not to communicate or contact any members of their downline for a period of one year from the date of transfer. Any refusal to comply with this agreement will result in the immediate termination of this account and the eventual adoption of further measures.
- e) We disclaim any and all liability arising from fraudulent entry and use of the Site. Funds will be transferred from the Platform's account to the specific Bitcoin address provided by the Member.
